4. Selection Method


- The applicant must submit the financial quotation along with the EOI.

- The bidder quoting the Lowest Price (L1) shall be called for negotiation, and the final price shall be fixed through negotiation with the L1 bidder.
- Submission of EOI does not automatically guarantee selection.
